

"The International Humanist and Ethical Union (IHEU) is appalled and deeply saddened by the attack on the offices of the magazine Charlie Hebdo in Paris, France, today. This is an horrific and profoundly illiberal attack. It is an act of Islamo-fascist terrorism, aimed at silencing freedom of expression about religious beliefs, and about Islam in particular.

No person who genuinely recognises the humanity of their fellow citizens, or who is remotely interested in the good of society at large or for any section of society, could ever justify this terrorism. Reading words and seeing images that satirise your beliefs is as far removed from a warrant to murder as it is possible to get.

Europe has a tradition of humanism, in which both freedom of expression, and freedom of thought and belief, including freedom of religion, are respected and upheld in law. To criticise beliefs, including through satire and ridicule, does not contravene others' freedom of belief. Rather, criticism is essential to freedom of expression. Murder on the other hand is the ultimate nullification of all a person's freedoms and being.

It is our true hope that Europe will neither bow to this violence, nor rise to it. We will not be provoked into an equal savagery. We will resist all terror, and we will defend freedom of thought and expression: essential values for free and meaningful lives."

NSW HUMANISTS ACTIVISM MEETINGS

What are Activism Meetings for?

While we have the best of intentions of doing activism during regular committee meetings, it does seem too easy to get distracted. So, an initiative of mine, was supported by the committee, was to have "activism" meetings - with our first in recent history held on the 11th January.

Doing "activism" - changing the world for the better - has always been a goal for us. Part of that is doing. Still, action informed by good thinking is always going to be better, and it gave me the opportunity to express some thinking that I've extracted from books like "Rules for Radicals", and "How to Win Campaigns".

In addition our meeting was also about building up connections and finding out what others are up to. One bit of feedback I had was that while the meeting was interesting, we didn't actually **conclude** anything about what we needed to do. Still, it is early days - and while I do hope we'll eventually get to practical outcomes, I think it is great that we can have more of our thinking a lot more focused around "activism" than at regular meetings.

We now plan to have activism meetings as a supplement to general committee meetings, instead of HuVATs. We'll still be running HuVATs - but perhaps once a quarter we'll have an "activist" meeting. We hope to have at least a few interesting guest speakers - so apart from anything else, we'll be able to learn what's going on and build connections.

I think our aims should be to:

- change the law - change policy - change implementation - empower people - change prevailing awareness

For sure, the legal system is what constrains us, and money is diverted along religious lines through parliament. Changing the laws and how they're implemented is important. But, at the same time, "can we ignore the government, and lead our better lives regardless of Government?". And that does lead to the other elements - empowering people and raising awareness. For sure, a lot of campaigning is around "raising awareness". But we need to be thinking - "how is the increased awareness going to result in a better world, with people more able to lead more worthwhile Humanist lives?". I think that's an important element. So too is the idea of a measureable outcome - if we're trying to change laws, well, when a new law is enacted that becomes much easier. But other things are less easily measured. Still, I think it helps to at least be aware of these issues.

Now, we can try to get the world changed by direct communication with individuals - so that we, as it were, have shared communication with all the foot soldiers. And that's a worthy goal - not just to have our ideas in circulation, but think about how our ideas can help people assert themselves so that individually - and as a group - we do better things.

Appealing to the outside world - Tragedies and Scandals

However, our in-principle supporters may not be so committed as to have directly opened their communication channels with us, and we have to think about how we can have "an issue" that resonates with people in the community-at-large. This is where we need to think about how "issues" might get traction with people-at-large.

And so, we need to understand the difference between "a tragedy" and "a scandal".

- A 'tragedy' is something which should not have happened.
- A 'scandal' is something that could have been dealt with.

Calling something a scandal means you can get added traction with the media and the outside world. Rather than merely being an issue of concern, it becomes linked up with some mistake in its handling by a greater authority - Government , Business - or even a Community which was unable to stop to recognise the problem. So, if we are going to get better media traction - we need to think in terms of "scandals" - and identify some party that is "causing" the problem.

The position of religion in society

Changing how religion is perceived in society would be great. The world has changed, and as compared to Bob Hawke being openly atheist - religion has now become a part of politicians' credentials. In addition, religious commentators can claim a special status - as compared to them merely being part of the political square.

An important objective would be for Secular Charities to obtain recognition from the Federal Government, and have the privileged position of religious charities devalued.

Separately to policies, however, it does appear Australia is becoming less tolerant of diversity - with believers being more able to marginalise atheists and others. So, at the same time as we push for our values, we also need to push for tolerance.

Australia was specified as a secular entity. This was forgotten because secularists are laid-back, with no 'missionary zeal'. Christians (e.g. Fred Nile) call Australia a 'Christian country'!

Guest Speakers at the 1st Activism Meeting

STEVE MAXWELL from the NSW Rationalists, spoke on behalf of Max Wallace (but not on follow-ups on Ron Williams' case.). Max is interested in Fiji, looking at having a secular state.

LIZ JACKA - board member of Dying with Dignity NSW - reported that Richard Di Natale (federal Greens senator) has legislation before parliament; many issues needing attention regarding the constitution. Canada has passed legislation, making appeals via their Bill of Rights. In UK, Lord Falconer's cross-parliamentary committee drafted a bill which was passed but Cameron opposed it. Apparently the idea is that no criminal charges if assistance is given on compassionate grounds. In NSW, we need a Falconer-style report.

JOSEF DAROCZY - Freethought Student Alliance - A big problem across Australia is to motivate people to become active, then remain active. Student discussion groups tend not to continue. We need goals to create something constructive that will outlive the people. JD wants to connect students to secularism in the wider community.

Comments - VB: Continuity is an issue in student circles. Scott Sharrad from South Australia seeks funding for students to attend CAHS Convention. ML: Should we advocate for Humanist Chaplains to compete with religious chaplains?

ZAC BLOOD Macquarie Uni Atheist League - Consolidating on membership Social group for like-minded people. Holding events in conjunction with Sci-fi and Physics groups. Watched 'Cosmos' - Held 'Ask an Atheist' stall on campus. - Looking for more activism in 2015 and increasing presence on campus.

Member Reports and Suggestions from the Meeting

- We have many good books and publications in our library. Could our library join the Library Society? (SM)
- We should try to adopt a think-tank role, get articles which could lead to talks of a quality that could get on to 'Big Ideas'. Need someone who can be interviewed (ML).
- We need to be a learning organisation, (therefore) we need new plans, concepts etc. (VB)
- We have a history, and have lasted 50 years, (therefore) we are perceived as "winners" this helps In gaining credibility, in addition to having good ideas & concerns. We have values and a philosophy. The concept 'Humanism' has gravitas (ML).

- We need something to show for our existence. Can survey members by phone. We're on Facebook, community radio (JA)
- HuVAT offers stimulating conversation (BW)
- School chaplaincy continues to be an issue. Also Religious school funding and Judeo-Christian heritage in syllabus.

DAVID NELSON - Suggests a public resource, Searchable Knowledge Base on issues related to Humanism etc. John A or other committee member to sponsor project.

Dr Affie Adagio has retired from the NSW Humanist Society Committee after fifteen years of service.

Affie served as President 2002-2005, and for very many years as Honorary Secretary and as Viewpoints Editor. She was Convenor of *Australis2000*, the first regional congress of the International Humanist Ethical Union. Affie attended CAHS AGMs on several occasions representing NSW, and served as Secretary of CAHS Executive 2000-2002. She organised many successful and entertaining End-of-Year Parties for the Society's members. Affie liaised with the UNAANSW and sustained a profitable working relationship between the two

organisations for many years. Her fundraising talents included persuading the NSW Premier to grant \$6000 to support UNAANSW in its tenancy at Humanist House. Founder and Convenor of HuVAT, Affie also successfully ran five prestigious International Women's Day events at Parliament House, sponsored by both HSNSW and UNAANSW. A highlight of her final year of officialdom, was organising a major World Humanist Day Symposium - (which she unfortunately missed due to her heart attack!)

Affie's innovative style, and experience as a counsellor, helped steer the Humanist Society of NSW through some difficult years, and her energy will be missed. The Committee thanked Affie for a splendid record of service, and showed appreciation with a bouquet of lovely farewell tulips.



NSW HUMANISTS PRESIDENT'S REPORT



Our end of year celebration was a great success, with merrymaking all round.

The editorship of our newsletter Viewpoints has changed - this is the inaugural issue edited by Murray Love. We extend hearty thanks to Frank Gomez, who has done such a sterling

job for the past several years. Such efforts and skill by volunteers does much for the effectiveness of the Society.

This summer we met with Roy Brown of IHEU and his wife Diana. He spoke on his experiences on the U.N. Human Rights Council, which seems to have lost sight of human rights, and is often dominated by its growing Islamic member states.

Our Humanist Viewpoints Afternoon Talks (HuVAT) each month continue to get our message across. On 28 January I spoke on Fundamental Physics and the Big Questions of Philosophy. This includes the influence of science and the Enlightenment as a rational basis for humanism.

Other HuVAT topics included The Ellis Defence, where the Catholic Church placed legal barriers between its billions of dollars of assets, and its child abuse victims. George Pell, who could be the next Pope, may have made decisions that draw out the suffering of victims.

Over the holiday break I took the chance to meet with other Humanists and like-minded groups. In January I met with many of the Victorian committee to discuss humanist matters. We compared the booming primary ethics lessons program in NSW, with the very successful philosophical ethics trials in Victoria, where there has been a 40% decline in Religious Education due to school principals cancelling the classes.

I am in my fifth year of teaching ethics at Balmain, where we now have 9 teachers, and reach 48% of the students! We are making a real difference in the next generation.

I sat in on the Royal Commission into Institutional Responses to Child Abuse. This helped see defence of human rights in action, and get an idea of what might lead to serial abuse and its cover up. The RC is costing \$320M. Good value it would seem!

John August gave a talk on Evolutionary Psychology to the Sydney Realists on 10 March, following Part 1 in 2014. The views are much in accordance with humanist beliefs. His talks are very well received with much discussion.

Open Forum weekly talk

This program, continuous for 43 years, presents expert speakers in controversial topics in religion, economics, politics etc. It includes many of interest to Humanists. See the program at: http://www.hsnsw.asn.au/mtgs

An earlier topic was the Israel-Palestine problem, with no solution in sight while both sides hold to fundamentalist and racist views.

The cost of child abuse was the topic at Open Forum (sponsored by HSNSW) on 11 March. Mr Nick Hossach estimated that lost government revenues alone are nearly seven billion dollars a year - pain and suffering not included!

Dr Wendy Lambourne on 25 March spoke on Justice After Genocide. What should be done after the killing has stopped to restore a decent society? Wendy described her work on reconciliation in Rwanda and Burundi.

CAHS Convention and Motions

Preparations continue for NSW participation in the CAHS Convention (Council of Australia Humanist Societies) to be held in Perth in 29-31 May 2015. All NSW members are welcome to attend – you might like to schedule a Western holiday.

On 8 March, HS-NSW held an SGM to formulate motions for the Convention. Motions already submitted by other states were discussed, and voted upon to determine our position.

To originate new NSW motions, the outcomes of the previous Activism meeting and of the Meetup discussions were reviewed. Ideas from the floor regarding current events were presented in a brainstorming session. A list of 10 ideas were finalized and voted upon. The most popular are:

With strong support:

- To oppose funding of chaplains in schools, while excluding secular welfare workers
- To express concern for social justice, in particular domestic violence, and support finding for women's refuges.
- To eliminate the privileged position of religion in charities.

With a lesser majority:

- That companies involving the supernatural pay normal tax & lose their financial concessions.
- To remove religious exemptions to anti-discrimination laws

Now HS-NSW is to draw up the most important (e.g. first 3) with a rationale in the required format. At the Convention, such motions from all States will be discussed and voted upon. Those carried will then become official CAHS policy and be the subject of letters and actions.

Nomination/selection of recipients of two Awards is in progress – Outstanding Humanist Achiever (OHA) – for active Humanist members, and Australian Humanist of the Year (AHOY) for known public figures advancing humanist causes.

Other Outreach

I met up with Kendric Frazier, - 40 years editor of the *Skeptical Inquirer* journal (and its predecessors). A group of Humanists and Rationalists took the opportunity to meet him for a relaxed lunch, in-depth discussions, and a tour of Cockatoo Island. He was here for the *Australian Skeptics International Convention* in November, which I attended, making contact with many leading overseas Skeptics and Humanists.

Several Humanists and friends attended the *Unholy Trinity Downunder Tour* on 13 March, which brought together three atheist activists. Matt Dillahunty, AronRa, and Seth Andrews took to the stage to share stories, interact with a live audience (and with each other), and address some of the challenges and opportunities in the fight against non-reason. It was a most enjoyable and humanist experience.

I built my fifth float for Mardi Gras — in this case a mobile Parliament House Canberra. Our VP, John August drove it, and I marched with it. It was organized by *Sydney Queer Atheists*, and supported by friendly groups. While not under a Humanist banner, it promoted many shared values from a human rights perspective, and protested against the permitted exemptions from Equal Opportunity legislation granted to religious organizations etc.


Sunday 14th June 2015, 4-6pm, Humanist House HuVAT (Humanist Viewpoints Afternoon Talk)

THE QUEBEC CHAIN-EMAIL MASSACRE*

I received one of those chain-emails recently. You've probably seen them. Often there's an emotive anecdote and/or political concern – missing children, heroism, conspiracy. They ask you to pass it on to everyone you know, so it becomes a campaign.

This one has a story about Muslims so was seen as topical, as well as expressing views they supported. I generally don't pass on chain emails myself, - but I suppose I'm doing so in a big way now by publishing this one in Viewpoints!

I was myself immediately appalled by the email, but learned that other Humanists saw it as giving opinions shared by many in Australia - views not always expressed 'for fear of being accused to be racist'.

First—is the story true? I found no mention of the incident on the official website of Dorval in Quebec. But my Google searches turned up an earlier version of the story set instead in Ath in Belgium. It was originally in the French language, but otherwise identical. The Ath official website did have a categorical denial of the story by the Bourgmestre (Mayor) Marc Duvivier .

The Belgian Mayor called the message a 'mensonge' which translates as 'lie'. Even French language news called it a 'hoax'. Snopes, and other skeptical websites, dismiss the English language version just as forcefully. Still, some Humanists say, the point is it would be good if it were true.

I guess they feel it's time someone took a stand and told Muslim immigrants how to behave in no uncertain terms. I can understand their fears and frustrations. Nevertheless I found this particular message disturbing and repellant. Now I know that people of goodwill can see things differently. So I'd like to take a closer look at the email, and explain my concerns in plain language. As the story spread to Australia, I will substitute our country in my analysis.

Firstly, it is not insignificant that it is false through and through. Someone made the story up in order to set up Muslims for a fall. How would you feel if someone deliberately lied to make you look bad? And would it in any way mitigate the pain, if everyone generally considered it a plausible story?

The message has a scolding and intimidating tone: "Muslims must understand that they have to_adapt ... to integrate... it is for them to change their lifestyle ...". This is a call to "shape up or ship out" addressed to a whole category of human beings. It could even be seen as expecting Muslims to start eating pork. Would anyone pressure Jewish people that way?

In any case, <u>do</u> migrants have to change lifestyles? Past migrants <u>did</u> have to adapt and integrate. Even change their names. But I thought we'd moved on from the attitudes Italian and Greek migrants endured in the post-war years. Isn't 'lifestyle' now a matter of personal choice? What's really left of 'freedom of choice', if your very lifestyle is dictated to you by local majority preferences?

The message is sarcastic: - "there are 57 beautiful Muslim countries in the world, most of them under-populated and ready to receive them with open halal arms". Does anyone else get or expect sarcasm, in letters from appointed or elected public officials? - OK it's not really from a public official, but it is meant to be imagined as such. Sarcasm is generally rude and unacceptable in correspondence. What does it mean if standards of good manners are dropped for a

particular kind of person? Surely official rudeness is demeaning, and the beginning of dehumanisation.

The directive tone continues with: "they must understand that in [Australia] with its Judeo-Christian roots, Christmas trees, churches and religious festivals, religion must remain in the private domain".

This statement seeks to establish so-called 'Judeo-Christianity' as a national tradition, and then demand all **other** religious manifestations be private only. The author seems to think there are established majority religions - and unestablished minority religions that need to know their place.

The message addresses "Muslims who disagree with secularism...". Perhaps some of us will see the word 'secularism' and feel this message reflects our values, but I ask them to think further. Secularism is not about privileging majority views, and still less about privileging local religious traditions. I suggest the author of this message has no understanding of secularism at all.

As a secularist myself, I draw no comfort from highly selective usage of 'secularism' directed only at minorities. Secularism isn't about separating just the unpopular 'churches' from the state. Secularism is in fact about one's right to be unpopular without suffering harassment from authorities.

The message insists that Muslims "must understand that [Australians] are neither racist nor xenophobic; they accepted many immigrants before Muslims". This is nonsensical - there is a well known history of rejecting foreigners and their foreign ways in all sorts of countries. This is an aggressive demand that no-one is to call the authors and supporters of the message a racist or xenophobe. (But perhaps it moves those who feel unjustly denied their own views for fear of such accusations).

It concerns me it's now often seen as far worse behavior, to accuse a particular fellow Australian of being 'racist', than it is to slur any of the less popular ethnic groups. And, of course, it can also be argued that Muslims aren't a race. So let's just leave 'racism' out of it! But who can hold me back from describing this chain-email message as xenophobic?

What's all this pork talk anyway? Kids don't have 'pork' for lunch. Surely it's ham that's in contention. Of course we all can agree that an Aussie kid can have a ham sandwich at his school tuckshop. The use of the word 'pork' seems deliberately symbolic and provocative. I think it shows this is mostly about identity rather than practical considerations.

The phrase "give up their identity" almost slips by us in reading the email, but I think it is actually the 'punch line' in the message. 'Identity' is the new obsession, and blood and ink get spilt over it. (I could substitute 'identist' for 'racist' but the *Apple iStore* has already taken the word for a software 'App' developed for use by dentists! (3)

There are catch cries to defend 'identity' coming from militant chauvinists of all stripes and both islamo-fascist and islamo-phobic extremists. People fear theft of their 'identity' and regard it as a possession. Ancient libel and modern vilification laws intrude, not to forget duels and honour killings. Many wars were fought to redraw boundaries around group identities - linguistic, ethnic and faith-based. Identity becomes sacred while the sacred is blurred into identity.

THE HOAX CHAIN-EMAIL IN QUESTION:

Let's hear it from a Quebec Mayor..!

MAYOR REFUSES TO REMOVE PORK FROM SCHOOL CANTEEN-MENU... EXPLAINS WHY!

Muslim parents demanded the abolition of pork in all the school canteens of a Montreal suburb.

The mayor of the Montreal suburb of Dorval has refused, and the town clerk sent a note to all parents to explain why...

"Muslims must understand that they have to adapt to Canada and Quebec, its customs, its traditions, its way of life, because that's where they chose to immigrate.

"They must understand that they have to integrate and learn to live in Quebec.

"They must understand that it is for them to change their lifestyle, not the Canadians who so generously welcomed them.

"They must understand that Canadians are neither racist nor xenophobic; they accepted many immigrants before Muslims (whereas the reverse is not true, in that Muslim states do not accept non-Muslim immigrants).

"That no more than other nations, Canadians are not willing to give up their identity, their culture.

"And if Canada is a land of welcome, it's not the Mayor of Dorval who welcomes foreigners, but the Canadian-Quebecois people as a whole.

"Finally, they must understand that in Canada (Quebec) with its Judeo-Christian roots, Christmas trees, churches and religious festivals, religion must remain in the private domain. The municipality of Dorval was right to refuse any concessions to Islam and Sharia.

"For Muslims who disagree with secularism and do not feel comfortable in Canada, there are 57 beautiful Muslim countries in the world, most of them under-populated and ready to receive them with open halal arms in accordance with Sharia.

"If you left your country for Canada, and not for other Muslim countries, it is because you have considered that life is better in Canada than elsewhere.

"Ask yourself the question, just once, 'Why is it better here in Canada than where you come from?"

"A canteen with pork is part of the answer."

(At some point in the chain all this was translated exactly from a French language original set in Belgium. I have viewed and checked the Francophone version which only added a finishing 'Bravo Mr le Bourgmestre!' Also note you can check for hoaxes yourself, at sites like www.snopes.com, www.hoaxbusters.org, and www.hoax-slayer.com.)

We 'defend to the death' an individual's right to choose their various identities in a multicultural society - even to be a 'multicultural individual' if they so choose! But we all 'face death' if we allow groups of shared identity to take up arms in defense of that identity, or to enforce it on their colleagues.

I think this hoax chain-email is a case of an identity warrior masquerading as a champion of justice. If we ever allow identity to be an excuse for coercion, we re-open everything that campaigners against bigotry have worked to close.

As a practical issue, I do believe it fair that there be halal alternatives if Muslim children attend a school. (Provided someone buys them – there's no need for wasteful symbolism). And people have the right to be different, even stupid, and to

peacefully pursue issues that have only minority support.

On the other hand I'm opposed to burkas in banks, separate law codes which disadvantage women, guns, bombs, violence, and any privileging of faith over reason. But my concerns are never to be muddled with bigotry and xenophobia (either blatant or in denial of itself).

There are rarely just two sides to any questions these days, but human adversarial thinking will always tend to see things in black and white. I like to call mine a 'nuanced' view, but recognize there are many other 'nuances' out there!

THE RIGHT TO MARRIAGE EQUALITY

Opponents of equal rights for homosexual people, particularly regarding same-sex marriage, predicate their opposition on ignorant misconceptions of human biology, and unsupportable reliance on religious precepts.

The Christian Democratic Party's Rev. Fred Nile, well known for his vehement opposition to same-sex marriage has even labelled homosexuality a 'mental disorder'.

A rather better-qualified opinion would be that of the late Dr Albert Ellis*, a world-renowned American sexologist and psychotherapist, who showed it is actually 'devout belief and religiosity' which 'contribute to, and in some ways are equal to, mental or emotional disturbance'.

Rev. Nile and his ilk pontificate that the status of 'marriage' should only be conferred upon the union of one man and one woman. Yet even the Macquarie Dictionary includes in its definition 'any intimate union'!

But, is the biological coupling process for perpetuation of the species, the be all and end all of marriage?

In December 2013, two years after the death of his first wife, Rev. Nile, aged 79, himself married a new spouse aged 55. There was no intention or likelihood of increasing the population. What qualities did such a marriage have that are unique to the sacrosanct formula of one man and one woman? Surely no rational person could claim that love and companionship are the sole province of heterosexuals!

Another resolute opponent of equal rights is Jim Wallace, Managing Director of the Australian Christian Lobby. His organization promotes 'Christian principles and ethics', blindly derived from misconstrued traditions, and the dubious authority of holy writ.

We might ask, what advantageously distinguishes specifically 'Christian values' from the existing mores of a society already embracing humanism and democracy? Doesn't such democracy by definition include, without qualification, equality of formal and social rights?

Jim Wallace is on record as claiming that smoking is healthier than gay marriage. His specious rationale was based on dated statistics and effectively repudiated in public debate by marriage equality advocate, and Greens Senator, Christine Milne.

The Australian Christian Lobby manifesto includes an undertaking 'to foster a more compassionate, just and moral society' - if you please!

There are two main reasons for opposition to same-sex partnerships: gross misunderstanding of human biology, and bigotry arising from religious delusions.

First - biology. In human development and experience there are obviously widely divergent preferences and attitudes. Sexual preference is just one such consideration and is justly entitled to free expression and societal endorsement. Within that range of human expression, gender-related distinctions in behaviour and appearance occur. Yet these do not necessarily indicate sexual preference.

Appearances can be deceptive. E.g. Men have nipples and can get breast cancer because, at the earliest embryonic stage, gender is indeterminate. Subsequent developments, both physical and mental, are subject to natural influences within

that wide range of biological potential. And some of the embryonic variation potential remains in evidence.

And human biology includes brain function; in other words, the mind - often misunderstood, notably by the religiously inclined, to be a separate entity and imaginatively referred to as the 'heart'.

Homosexuality may be a minority phenomenon, but it is incontrovertibly natural. Homosexual behaviour has been documented in over 500 animal species.

It cannot seriously be suggested that so many who 'come out' after decades of suffering their sexual proclivities in socially enforced secrecy do so out of some developed fantasy to be different or outrageous, as has been claimed. It is clearly a matter of ontology - not choice.

Next - religious delusions. These result from two main assumptions: the existence of an almighty deity; and that the Bible is this deity's infallible instruction manual.

There is no credible evidence to support the first assumption, and the Bible is an incomprehensible, anonymous, contradictory, unsubstantiated, superstitious, misinterpreted collection of unoriginal manuscripts cobbled together centuries after the alleged events by a partisan committee! Further, it was compiled without benefit of modem science and allied enlightenment, and has been significantly edited over time.

The Bible supports slavery and the subordination of women; it tells of a loving God who orders and condones wars and atrocities, and who decrees death for minor infractions of the law. If such are its teachings, the Bible's dicta on homosexuality may well be cited as just further instances of abhorrent, misguided doctrine. Why should condemnatory biblical pronouncements on homosexuality be given any credence?

In rejecting the authority of the Old Testament, we have the backing of none other than Rev. Nile. On the ABC's Q&A programme in May 2013 he airily dismissed the entire Old Testament as of 'no modern relevance'.

Bear in mind, too, that of all the sayings and teachings attributed (rightly or wrongly) to Jesus in the New Testament, none broached the subject of homosexuality. At most, it can be said that he advocated upholding the law contained in the very same Old Testament Rev. Nile dismisses.

As a final biblical consideration, we might note the role of (Saint) Paul in condemning homosexuality in the New Testament epistles still attributed to him.

What of this icon of the Christian faith? Paul, formerly Saul, began as a morally and socially corrupt professional thug, and self-confessed persecutor of Christians. His famous 'change of heart' en route to Damascus, supposedly triggered by a vision of Jesus, is nowadays more reasonably attributed to visual and auditory hallucinations. And all this followed by an egotistic personal claim and conviction he'd been singled out by God to be of signal authority. Can it be imagined that, today, such events would be accepted as leadership qualifications?

If the male plus female formula and its potential for procreation, is the only permissible foundation for the status of marriage there are other obvious questions.

What of heterosexual couples who choose not to, or can't, have children? Is their marriage required to be invalidated - or

forbidden in the first place by way of a preliminary official questionnaire? - Of course not.

And if annulment or prevention of a childless heterosexual marriage is not a moral, social or legal requirement, then by what standard and to what purpose can it be asserted that heterosexual marriage is innately valid and uniquely superior?

In the event that a heterosexual couple can't, or decline to, have children there remains a supportive partnership founded on love and companionship, and still endorsed by society. Indeed, shouldn't love and companionship be the very basis of human partnership - as distinct from a primordial reproductive function?

Given all these considerations, how would same-sex marriage detract, as it often claimed, in any way, from the social acceptance of partnerships as discussed - and referred to as 'marriage'?

As a concluding observation, concerning adoption of children, it is often claimed by opponents of equality that the effective nurture of children depends on there being a mother and a father.

I suggest that in today's diversified society balanced child nurture can be achieved regardless of parental gender considerations.

And I contend that, in terms of human welfare, freedom of sexual expression will prove far more beneficial than the misguided machinations of the religious, and others, who seek to deny it. In this matter of equality, it is high time we, as a civilized society, ceased being in thrall to the bigotry of ignorance, and the moral and political tyranny of unsubstantiated religious beliefs.

*Albert Ellis (1913-2007) was a famous American psychologist. In 'The Case Against Religiosity' he wrote "This article will try to make a succinct and cogent case for the proposition that unbelief skepticism and thoroughgoing Atheism not only abet but are practically synonymous with mental health;

and that devout belief, dogmatism, and religiosity distinctly contribute to, and in some ways are equal to mental or emotional disturbance. The case against religiosity that I am about to make ... is only presented as a firm (and undevout!) hypothesis that I believe has validity but that, like all scientific hypotheses, is tentative and revisable in the light of later substantiating or nonsubstantiating evidence".

She loved going to the movies and seeing quality films. I could always rely on her assessments regarding books to read and films to see. She loved plays and the opera. We accompanied her to many of these over the years. She had an active and engaged mind up until the end. In her last weeks whilst in hospital, her primary request was to have her glasses and enough cash to buy the Herald each day, and that kept her happily occupied. ...

"Lyn believed in bettering the lives of human beings on Earth. She was a long term member of the Australian Humanist Society and met many friends through that organisation. Through the Humanist Society she was actively involved in many social causes including the decriminalisation of prostitution and ensuring the availability of abortion. She was also an active member of the Voluntary Euthanasia Society. I have no doubt that the environment of social activism that I grew up with was a shaping influence for myself and my own choice of career in Social Work. I know she was delighted with my choice and always took an interest in what I was pursuing."

To which I say yes very much so, and which we Humanists much appreciate to this day.

Aussie Lyn was born in 1924 in Melbourne and through work came to know a new culture which developed in Sydney after WW2, of European Jewish refugees that arrived under post war migration. From this association she met her husband Stephen, with whom she begat two children Anne and Michael.

Today we are honoured that her son Michael has chosen to become a member partly to replace his mum. Thanks Michael - your membership is much appreciated!
